1.1 PROMOTION OF ACCESS TO INFORMATION ACT

The 1996 South African Constitution, by providing a statutory right of access on request

to any record held by the state as well as access to records held by private bodies,

entrenches the fundamental right to access to information.

The Promotion of Access to Information Act became operative, giving effect to the

constitution right of access to any information held by the State and any information that

is held by another person and that is required for the exercise or protection of any rights;

and to provide for matters connected therewith [Section 32(2)].

This document is Maxidor SA (Pty) Ltd information manual and provides reference to the

records held by Maxidor SA (Pty) Ltd and the process to request access to such

records.

7. ACCESS REQUESTS

7.1 ACCESS REQUEST PROCEDURE

The requester must complete Form A (Provided in Section 8 of this manual) and submit this form together with a request fee, to the head of the private body.

7.2 COMPLETION OF ACCESS TO INFORMATION FORM

The form must:

- provide sufficient particulars to enable the head of the private body to identify the record/s requested and to identify the requester,
- · indicate which form of access is required,
- · specify a postal address or fax number of the requester in the Republic,
- identify the right that the requester is seeking to exercise or protect, and provide an explanation of why the requested record is required for the exercise or protection of that right,
- if in addition to a written reply, the requester wishes to be informed of the
 decision on the request in any other manner, to state that manner and the
 necessary particulars to be informed in the other manner,
- if the request is made on behalf of another person, to submit proof of the capacity in which the requester is making the request, to the reasonable satisfaction of the head of the private body.

7.3 SUBMISSION OF ACCESS REQUEST FORM

The form must be submitted to the head of the private body at his/ her address, fax number, or electronic mail address.

7.4 PAYMENT OF FEES

To facilitate our processing of your request, please note the following: As per Government Notice No. R187 of 15 February 2002, the following applies to requests (other than personal requests requesting personal information about the requester):

- A requestor is required, on notice from the private body in compliance with s54 of the ACT, to pay the prescribed fees before a request will be processed
- If the preparation of the record requested requires more than the prescribed hours, a deposit shall be paid
- A requestor may lodge an application with a court against the tender/payment of the request fee and/or deposit
- Records may be withheld until the fees have been paid
